The SC Licensing Examinations are designed to set a minimum standard of competency required of individuals who wish to act as intermediaries in the Malaysian capital market.

It is designed as a learning tutorial covering the knowledge and skills relevant for Marketing Representatives (as defined under the Guidelines for Marketing Representatives) to carry out their duties competently and in compliance with prevailing laws and regulations.

The broad spectrum of e-learning tutorials will provide a comprehensive introduction to the Malaysian capital market covering the regulatory framework, capital market products and services as well as the techniques and skills required in marketing capital market products and closing the deal with prospective clients. Upon completion of this learning programme in accordance to the recommended learning hours, participants will be better prepared to undertake the FPMR Assessment.

#### **eFAMILIARISATION PROGRAMME FOR TRADING REPRESENTATIVES (eFPTR)**

#### eFPTR I

The eFPTR I is a self-directed online learning programme offered via the SIDC Learning Management System (SIDC eLearn) platform comprising of 11 modules. It is designed as a learning tutorial covering the knowledge and skills relevant for Trading Representative (TRs) (as defined in the Licensing Handbook) to carry out their duties competently and in compliance with prevailing laws and regulations. The broad spectrum of e-learning tutorials will provide a comprehensive understanding of the Malaysian securities market for Trading Representatives (TRs) working with Participating Organisations (POs) to carry out their duties effectively and in compliance with the law.

#### eFPTR II

The eFPTR II is a self-directed online learning programme offered via the SIDC Learning Management System (SIDC eLearn) platform comprising of 16 modules. It is designed as a learning tutorial covering the knowledge and skills relevant to individuals who have passed the FPTR I (or previous FPRR I) assessment and intend to apply for a Capital Market Services Representative's Licence (CMSRL) to carry on the regulated activity of dealing in securities.

#### CERTIFIED CAPITAL MARKET PROFESSIONAL: DEALING IN DERIVATIVES FOR DEALER'S REPRESENTATIVE (CCMP)

The Certified Capital Market Professional: Dealing in Derivatives for Dealer's Representative programme (CCMP – Dealing in Derivatives), previously known as Dual Licensing Fast Track Learning Programme (DLFT) comprises the following three (3) components: (i) e-learning programme, (ii) trading simulation and (iii) assessment.

The CCMP – Dealing in Derivatives eLearning Programme, is a self-directed e-learning programme offered via the SIDC Learning and Assessment Management System (LAMS) platform comprising of six (6) modules. The CCMP – Dealing in Derivatives eLearning Programme is designed as a learning tutorial covering the knowledge and skills relevant for qualified Capital Markets Services Representative's License (CMSRL) holders for dealing in securities, who are seeking to be additionally licensed for dealing in derivatives. The CCMP – Dealing in Derivatives Trading Simulation which is also offered via the SIDC LAMS platform, will provide candidates with the opportunity to apply and practice what they have learned as it mirrors the actual trading platform.

#### **ANTI-MONEY LAUNDERING (AML) SERIES - PART 1**

Money laundering is a potential indicator of terrorist funding and other global crimes, making it necessary for practical training on AML. This is the first part of online AML training comprising 7 series and is intended to lay down the foundations of AML principles, requirements and expectations prescribed by the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 (AMLA) and the relevant guidelines issued by Securities Commission Malaysia. Each series is interspersed with short assessments to ensure effective learning of each participants.

#### **ANTI-MONEY LAUNDERING (AML) SERIES - PART 2 CASE STUDIES**

Money laundering is a potential indicator of terrorist funding and other global crimes, making it necessary for practical training on AML. This is the second part of the online AML series comprising 2 case studies and is intended provide practical insights on AML principles, regulation and expectations prescribed by the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 (AMLA) and the relevant guidelines issued by Securities Commission Malaysia. Each series is interspersed with short assessments to ensure effective learning of each participant.

The 2 mini cases are based on real-life cases to enable participants to recognise and understand regulatory expectations, relevant issues, obligations and prescribed penalties in the prevention of money laundering and terrorism financing from a practical capital market related perspective.
