PROGRAMME OVERVIEW ISLAMIC CAPITAL MARKET TALENT DEVELOPMENT (ICMTD)

Offered since 2009, the **Islamic Capital Market Talent Development (ICMTD) programme** (formerly known as the *Islamic Capital Market Graduate Training Scheme (ICMGTS)*) is a capacity-building initiative by the Securities Commission Malaysia (SC) and run by the Securities Industry Development Corporation (SIDC) to facilitate the development and upskilling of human capital for the Islamic Capital Market (ICM). Its main objective is to produce entry level professionals with strong fundamental knowledge and skills for the industry. Since its inception, the programme has produced a total of 23 cohorts with 940 participating graduates.

The framework and structure for the ICMTD programme has been elevated to equip its graduates with the knowledge and skills that are suited for client advisory roles in offering capital market products and services. The ICMTD is an industry focused programme and comprises internship opportunities for selected participants* to kickstart their careers in ICM, thus simultaneously channelling fresh talents for future developmental needs of the Malaysian capital market.

PROGRAMME MODULES INTENSIVE FACE-TO-FACE CLASSROOM TRAINING (2 MONTHS) + INTERNSHIP (3 MONTHS) FOR SELECTED PARTICIPANTS*

The ICMTD programme consists of 2 months of intensive face-to-face classroom training for all, followed by a 3-month internship at participating organisations for selected participants^{*}. The intensive face-to-face classroom training includes technical modules, soft skills modules and e-learning modules anchored on five (5) pillars i.e. Islamic Capital Market, Core Capital Market, Technology, Sustainability and Self-Development. The programme will be delivered through a wide variety of methodologies which include face-to-face classroom, hands-on workshop, facilitated business simulation project on fund management, case study discussions, presentations, e-learning and career development support.

^t There is limited internship placement available and participants will be selected based on their overall performance during the assessment to join the programme.
