Technical: Technical/professional skills and specialist knowledge to assist with ongoing aspects of the board's role

Governance: The essential governance knowledge and understanding all directors should possess or develop if they are to be effective

Behavioural: The attributes and competencies enabling individual board members to use their knowledge and skills to function well as

team members and to interact with key stakeholders
